Asics Falmouth Road Race

The 49th running of the Falmouth Road race is scheduled for August 15, 2021. The runners have been capped at 8,000. There will also be an at home addition beginning August 7th through August 14th. See www.falmouthroadrace.com for additional details.

Neighborhood Clean Up Event

The annual FHMNA clean up morning was held on April 24th on an individual/couple basis while social distancing. The spirit and camaraderie of the volunteers was wonderful.

Mayflower Wind, a joint venture project between Shell and EDP Renewables, is in the early phases of planning an 804-megawatt wind farm located 30 miles south of Martha's Vineyard on the Atlantic Coast Outer Continental Shelf. The Conservation Commission and the Select Board have approved limited, localized geotechnical boring investigations for the purpose of supporting the planning and design of a proposed Horizontal Directional Drilling landing of a submarine export cable at 0 Surf Drive and 0 Grand Avenue (end of Worcester Court). This does not obligate the Town to become a host community or approve future applications. The Town Manager has selected and engaged Exponent Corporation as an independent consultant to advise the town on this project. 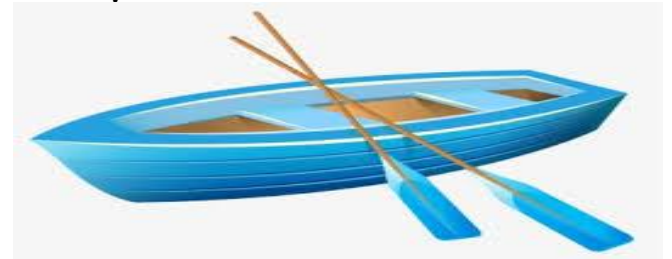
